Notification of ESB's section 36 application (6^{th} Jan) to construct a windfarm at West Torrisdale (above Torrisdale Castle) had been received ref. ECU 00002224. The

windfarm will comprise 9 turbines upto 150m in height positioned on the East side of the Kintyre ridge (making it an unprecedented development) that will be highly visible/impactful from Carradale point/fort/Torrisdale Bay.
