1. Apologies for Absence

2. Minutes and actions agreed/outstanding at previous meeting (Tuesday 10th August)

4. Correspondence with wind farm operators/developers

- Notification had been received that PI Renewables had applied to extend their options over their Eascairt windfarm development.
- The latest correspondence received from Energiekontor highlighted their desire to advance their proposed developments at Narachan and Kilberry, while Arnicle advancement had been put 'on hold', at least for the time being. It was agreed that AB should establish another meeting to advance the dialogue with EK over community shared ownership (CSO) ambitions at the two developments being progressed in the region [**Action: AB**]

A communique lending support to EKREG's goal to have CSO made a mandatory requirement for all new windfarm developments across Scotland had been received from Brendon O'Hara MSP. It was agreed that the EKREG briefing document allied to CSO and the problems experienced therewith should be updated and recirculated to previous recipient MSPs for them to action (incl Jenni Minto and Donald Cameron) and also to Green Party MSPs (incl Arianne Burgess, Lorna Slater and Mark Ruskell) - with a view to gaining cross-party support [**Action: AB/JB to follow up**]
