9. Community Asset Transfers - FLS - Hydro/Wind

 4 x local EOIs submitted – further information awaited from FLS nb. guide for hydro financials: 100 KW hydro produces 393,000 kw/h. ≈40 houses.

10. Sheirdrim/Blary Hill/Killean - Discussion with WKCC

- Sheirdrim/Killean/Narachan/HC consultation with WKCC provided a green light to pursue CSO discussions on behalf of joint CCs. With the caveat that strong objections to Sheirdrim and Narachan likely to be lodged by communities impacted
- RES Meeting aka Killean CSO scheduled Mon Dec 2nd Waterfoot [Apologies RE] have announced that they intend to pay no CBFs associated with their (relatively small) Blary Hill development (now at build stage). A one-off 30k payment will, however, be made when the site is operational.

13. CBS Model Rules

- Various model options were tabled and discussed
- There was unanimous agreement on the option choices made and it was agreed that Somerset model rules should be explored further [RL]

14. AOCB

- Grant available £750 to pay for travel/accommodation to learn/share knowledge with other community groups. Flagged by Moray-based windfarm team keen to learn from EKREG experiences
- Need to consider involvement Southend CC in CSO for Tangy as have long got CBF monies from Tangy
- The potential benefits of a meeting with local MSP Michael Russell to flag the activities of EKREG was agreed [AB to make contact post-election aka meet in New Year]
- It was also agreed that when the timing 'was right downstream' a meeting with Head EIF investment bank/Paul Wheelhouse and ? might assist EKREG cause and development of generic CSO model
- Contact information for newly-appointed Head A&B Planning Dept to be researched with a view to establishing a downstream 'positioning' meeting/briefing [JB]
