1. Apologies for Absence

7. Clachaig Glen

The project remains 'on hold' following consent for the development by the Scottish Government. The developer has applied for planning permission to create an overhead connection to Carradale sub-station

Planning application made by the developer allied to Clachaig Glen for overhead connection into Carradale sub-station could/would also service this development. No other updates to report.
